ORDER CALLING AN ELECTION

THE STATE OF TEXAS §
COUNTY OF DALLAS §
SUNNYVALE INDEPENDENT SCHOOL DISTRICT §

WHEREAS, by an order adopted by the Board of Trustees of the Sunnyvale Independent School District (the "District") on March 6, 2007 (the "Original Order"), the Board of Trustees has deemed it advisable to call the bond election hereinafter ordered (the "Election"); and

WHEREAS, following the adoption of the the Original Order by the Board of Trustees, the District was notified by the Dallas County Elections Administrator (the "Elections Administrator") of additional polling places for early voting for the Election, which will be administered by the Elections Administrator, and it is therefore necessary for the Board of Trustees to adopt this order amending and restating the Original Order to provide for such changes in polling places (for convenience of reference, the Original Order is being restated herein in its entirety, but the Original Order, except as amended hereby, remains in force and effect from the date of original adoption thereof); and

WHEREAS, the Board of Trustees of the District deems it advisable to call the Election; and

WHEREAS, Section 11.0581 of the Texas Education Code requires that for board of trustee elections, the Board hold its trustee election with a municipality in the District as a joint election; and

WHEREAS, the bond referendum and the District's trustee election are subject to the provisions of Section 11.0581, Texas Education Code, and the District is contracting to jointly hold the Election with the Town of Sunnyvale and other Dallas County, Texas (the "County") political subdivisions that are parties to an interlocal agreement known as the Joint Election Agreement and Election Service Contract (the "Election Services Agreement"); and

WHEREAS, the County, acting through the Elections Administrator in accordance with the Election Services Agreement will provide for the administration of the Election; and

WHEREAS, it is hereby officially found and determined that the meeting at which this Order was adopted was open to the public, and public notice of the time, place, and purpose of the meeting was given, all as required by the Texas Government Code, Chapter 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF SUNNYVALE INDEPENDENT SCHOOL DISTRICT:

1. An election shall be held between the hours of 7:00 a.m. and 7:00 p.m. on May 12, 2007 in the District at the following designated polling place:

Town of Sunnyvale City Hall
127 Collins Road
Sunnyvale, Texas 75182

Early voting shall be conducted for all voters by personal appearance and mail at the designated early voting polling places administered by the Elections Administrator, as set forth in Exhibit A hereto.

2. The appointment of the presiding election judges, alternate judges, early voting clerks, the presiding judge of the early ballot board and other election officials for the Election shall be made in accordance with the Election Services Agreement. The Elections Administrator may employ other personnel necessary for the proper administration of the Election, including such part-time help as is necessary to prepare for the Election, to ensure the timely delivery of supplies during early voting and on election day, and for the efficient tabulation of ballots at the central counting station, which will be established in accordance with the Election Services Agreement.

3. The Elections Administrator shall serve as the early voting clerk in accordance with the terms of the Election Services Agreement. During the period early voting is required or permitted by law, being April 30, 2007 through May 8, 2007, the hours designated for early voting by personal appearance shall be as set forth in Exhibit A hereto. The early voting clerk shall keep the early voting place open during such hours for early voting by personal appearance. The main early voting polling location for the Election shall be as follows:

4. As early voting clerk, the Elections Administrator shall receive applications for early voting ballots to be voted by mail. An early voting ballot board ("EVBB") and signature verification committee shall be created to process early voting results from the Election. The County shall appoint the EVBB in accordance with the Election Services Agreement to process early voting results from the Election. The presiding judge of the EVBB, with the assistance of the Elections Administrator, shall appoint two or more additional members to constitute the EVBB. The Elections Administrator shall determine the number of EVBB members required to efficiently process the early voting ballots

5. All resident, qualified electors of the District shall be entitled to vote at the Election.

6. A substantial copy of this Order shall serve as proper Notice of the Election, and the President of the Board of Trustees shall cause the Notice to be published one time, not earlier than the 30th day or later than the 10th day prior to the date set for the Election, in a newspaper published in the District or, if none is published in the District, in a newspaper of general circulation in the District. In addition, not later than the 21st day prior to the date set for the Election, the President

of the Board of Trustees shall cause the Notice to be posted on the bulletin board used for posting notices of meetings of the Board of Trustees.

7. At the Election the following PROPOSITION shall be submitted in accordance with law:

PROPOSITION

Shall the Board of Trustees of the Sunnyvale Independent School District be authorized to issue the bonds of the District, in one or more series, in the aggregate principal amount of \$25,000,000 for the purpose of acquiring, constructing and equipping school buildings, to-wit: constructing a new high school, with any surplus funds to be used to renovate and equip existing school facilities and to acquire school buses, with the bonds to mature, bear interest, and be issued and sold in accordance with law at the time of issuance; and shall the Board of Trustees be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes, on all taxable property in the District, sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds and the cost of any credit agreements executed in connection with the bonds?

8. The official ballots for the Election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote "FOR" or "AGAINST" the aforesaid PROPOSITION with the ballots to contain such provisions, markings and language as required by law, and with such PROPOSITION to be expressed substantially as follows:

9. In all respects, the Election shall be conducted in accordance with the Texas Election Code (the "Code"). Pursuant to the federal Help America Vote Act ("HAVA") and the Code, at each polling place there shall be at least one voting system that is equipped for disabled individuals, and each such voting system shall be a system that has been certified by the Texas Secretary of State as compliant with HAVA and the Code.
